


METHODOLOGY

Quantitative survey targeting the general population in Bosnia and Herzegovina aged 15+ and living in the country

1005 respondents randomly selected through a two-stage stratified sampling design with cities/towns/settlements as Primary Sampling Units (PSUs) & individuals as Secondary Sampling Units (SSUs)

Face to face interviews (field work) conducted in May-June 2025 and covering the following topics:

- o Information, awareness and perceptions of the EU
- EU relations with Bosnia and Herzegovina and awareness of EU's financial support
- Agreement on common narratives
- Public perceptions of the EU accession: support, expectations and concerns
- Institutional trust and national challenges
- Source of news and information





To what extent are you informed about the European Union?





Do you have a very positive, fairly positive, neutral, fairly negative or very negative image of the European Union?




56% of citizens have a positive image of the EU

In your opinion, which factors could make citizens of Bosnia and Herzegovina more positively disposed towards the EU? And which is the most important?




The **most important factors** that have been more frequently indicated are the following:

- 1. Support to Bosnia and Herzegovina's economic development (28%)
- 2. Support for reducing corruption (20%)
- 3. Support to Bosnia and Herzegovina's security (12%)



Trust towards the EU & other international institutions









Have you read, seen or heard or looked for any information about the EU in the last three months?








In general, how would you say the EU was presented in traditional media (i.e., television, radio and or newspaper) and In social media?







In general, how would you describe the relations that the European Union has with Bosnia and Herzegovina? Would you describe them as very good, fairly good, fairly bad or very bad?








Perceptions of financial support to Bosnia and Herzegovina from international actors

In your opinion, what is the level of financial support to Bosnia and Herzegovina from each of the following?




Which of these do you believe is the largest financial contributor to Bosnia and Herzegovina?




EU's financial support

- 3. Employment opportunities and workforce skill development (8%)








Perceived knowledge and support for EU accession

To what extent do you consider yourself well informed about Bosnia and Herzegovina's process of integration into the EU?




Overall, do you personally support or oppose Bosnia and Herzegovina's accession to the EU?






Perceptions of EU membership and referendum intentions

If a referendum about Bosnia and Herzegovina's membership in the EU was held this week, how would you vote?




Would you say that becoming a member of the EU would bring more advantages or more disadvantages to you personally? And to Bosnia and Herzegovina?

What do you think would be the main benefits of Bosnia and Herzegovina becoming a member of the EU?




Top perceived benefits of EU membership (respondents' first-choice responses):

- 1. Open borders, possibility to travel to other EU countries without a visa (12%)
- 2. Better future for children (11%), Peace and security for Bosnia and Herzegovina and the region (11%) and Rule of law, democracy and contribution to respect for fundamental rights (11%)
- 3. Better quality of life and standard of living (10%) and Fight against corruption and organised crime (10%)

What do you think would be the main concerns of Bosnia and Herzegovina becoming a member of the EU?




Top perceived concerns of EU membership (respondents' first-choice responses):

- 1. Youth drain, emigration (24%)
- 2. Exploitation of natural resources of the country (12%)
- 3. Drop in living standard (7%)




Perceived timeline and barriers to EU accession

When do you personally think Bosnia and Herzegovina will fulfil the accession criteria and become an EU Member State?




In your opinion, what are the main obstacles currently preventing Bosnia and Herzegovina from becoming a member of the EU?







Shifting attitudes towards the EU and growing security concerns

How would you describe your feelings about the current security situation in Bosnia and Herzegovina?







Trust levels across key institutions and systems


Please tell us which is your level of trust for following institutions, organisations and systems











Most pressing problems in BOSNIA AND HERZEGOVINA

- 3. Rule of Law (9%) and Poverty (9%)





Main sources of news and information


Which of the following information channels do you use on a daily basis to inform yourself or to follow the news?






Most used social media and TV channels for news
