
METHODOLOGY

Quantitative survey targeting the general population in North Macedonia aged 15+ and living in the country

1000 respondents randomly selected through a two-stage stratified sampling design with cities/towns/settlements as Primary Sampling Units (PSUs) & individuals as Secondary Sampling Units (SSUs)

Face to face interviews (field work) conducted in May 2025 and covering the following topics:

- o Information, awareness and perceptions of the EU
- EU relations with North Macedonia and awareness of EU's financial support
- Agreement on common narratives
- Public perceptions of the EU accession: support, expectations and concerns
- Institutional trust and national challenges
- Source of news and information




# AWARENESS AND PERCEPTIONS OF THE EU

36%


of citizens say they are **well or very well informed** about the EU

Do you have a very positive, fairly positive, neutral, fairly negative or very negative image of the European Union?




**65%** of citizens have a **positive image** of the EU

In your opinion, which factors could make citizens of North Macedonia more positively disposed towards the EU? And which is the most important?




The **most important factors** that have been more frequently indicated are the following:

- Support to North Macedonia's economic development (26%)
- 2. Support to North Macedonia's closer integration process (18%)
- 3. Support for reducing corruption (15%)


I would like to ask you a question about how much trust you have in certain institutions/countries. For each of the following institutions/countries, please tell me if you tend to trust it or tend not to trust it.







#### Information exposure and media tone

In general, how would you say the EU was presented in traditional media (i.e., television, radio and or newspaper) and In social media?







In general, how would you describe the relations that the European Union has with North Macedonia? Would you describe them as very good, fairly good, fairly bad or very bad?








# Perceptions of financial support to North Macedonia from international actors

In your opinion, what is the level of financial support to the North Macedonia from each of the following?




Which of these do you believe is the largest financial contributor to North Macedonia?




#### EU's financial support

- 3. Fighting corruption and better law enforcement (9%), Support to youth (9%)




### PUBLIC PERCEPTIONS OF THE EU ACCESSION: SUPPORT, EXPECTATIONS AND CONCERNS






#### Perceived knowledge and support for EU accession

Overall, do you personally support or oppose North Macedonia's accession to the EU?








# Perceptions of EU membership and referendum intentions

If a referendum about North Macedonia's membership in the EU was held this week, how would you vote?




Would you say that becoming a member of the EU would bring more advantages or more disadvantages to you personally? And to North Macedonia?

What do you think would be the main benefits of North Macedonia becoming a member of the EU?




**Top perceived benefits of EU membership** (respondents' first-choice responses):

- 1. Better quality of life and standard of living (19%)
- 2. Open borders, possibility to travel to other EU countries without a visa (17%)
- 3. Financial support of the EU: aid, donations, investment (11%)

What do you think would be the main concerns of North Macedonia becoming a member of the EU?




**Top perceived concerns of EU membership** (respondents' first-choice responses):


- 1. Youth drain, emigration (32%)
- 2. Loss of our cultural identity and traditional values (7%)
- 3. More bureaucracy (6%), the EU imposes too many regulations, limits national freedom (6%)




#### Perceived timeline and barriers to EU accession


When do you personally think North Macedonia will fulfil the accession criteria and become an EU Member State?








In your opinion, what are the main obstacles currently preventing North Macedonia from becoming a member of the EU?







#### Trust levels across key institutions and systems


Please tell us which is your level of trust for following institutions, organisations and systems






#### Most pressing problems in NORTH MACEDONIA

- 3. Healthcare (11%)





#### Main sources of news and information


Which of the following information channels do you use on a daily basis to inform yourself or to follow the news?






#### Most used social media and TV channels for news
